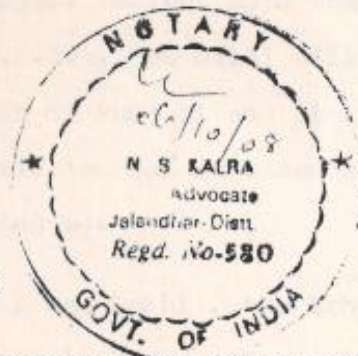

2. In your school the study of Punjabi subject upto the 10th class will be compulsory and C.B.S.E. New Delhi will act compulsorily to take examination of Punjabi and it is also stated that No Objection Certificate can be taken back immediately, if failure in doing so.
3. After affiliation with C B S E, New Delhi, the School Management of the School, will be liable to give salaries and other allowances to Teaching Staff and non-teaching staff as per salaries of Government Employees. The No Objection Certificate can be taken back if failure in doing so.
4. You and your Management should ensure that if any information is asked for by Distt. Education Officer of your District or any Senior Official of Education Department, necessary required information will be made available to him and necessary co-operation will be given to him.
